GBC's finest accomplishment of 2020, its inaugural conference, drew many positive accolades:

I liked the à la carte options!" s we look back over our first fifteen years, it is indeed worth celebrating how far we have come and look forward to how far we can go. Visionary Joe Sehee founded the Green Burial Council fifteen years ago in the spring of 2005, together with a host of experts from the fields of sustainable landscape design, restoration ecology, conservation management, law, and consumer affairs. Together they developed the first set of environmental standards for green cemeteries and the funeral professionals and product manufacturers that support them. Currently the GBC is the only independent environmental certification organization in the United States setting verifiable standards for green burial in North America.

GBC has grown to two distinct nonprofit entities: the first, Green Burial Council, Incorporated, is a 501c6 certification and provider support organization; and the second, Green Burial Council International, is a 501c3 educational and outreach organization. Both work together to further the movement toward more sustainable death-care options, support those who are actively engaged in green burial activities, and to raise awareness and serve families seeking a natural ending.

2020 was a landmark year for the Green Burial Council, with robust programmatic activity that generated surplus revenue which is being used to build critical capacity. For the first time in many years, we are hiring for a leadership position to strengthen our programs and deepen our impact in the community. We got to where we are today because of our providers, volunteers, sponsors, donors, educators, advocates, activists, and subscribers. GBC is very grateful to our providers who choose to follow and uphold certification requirements and standards; volunteers for contributing their time, skills, and expertise; sponsors and donors for their generous financial support; educators, advocates, and activists who spread the word; and for our subscribers' interest. A heartfelt thank you to each and every one of you for your efforts, time, and financial contributions in support of GBC and its mission to inspire and advocate for environmentally sustainable, natural death care through education and certification.

Conference Highlights

A slate of experts shared their knowledge, not only as presenters but also while attending sessions as participants. Attendees eagerly soaked in best practices and detailed plans, and many came to learn about green burial so they could advocate for it in their own communities. Representatives of long-established funeral homes and



cemeteries came to learn more about GBC certification, how they could better embrace best practices, and how to increase their green options as public demand grows in their local markets.

- GBC-certified provider maps were added to the website for locating cemeteries, funeral homes, and product providers in North America
- Certificates of Proficiency in Green Funeral Service were awarded to seven mortuary school students
- Newsletter was sent to an average of 4,500 subscribers monthly
- Social media activity grew considerably on Facebook, Instagram, LinkedIn, and Twitter
- YouTube channel was created



- Facebook group Green Burial Council Peer Forum was created for green burial practitioners and advocates to connect as an online community
- Participation was promoted for the FTC Funeral Rule review process

- Document creation, editing, and sharing was set up for the first time on shared drives for the boards of directors

Ariel Leath provided marketing strategy support.




